The proposed educational institutions shall start other projects deemed to be fit and proper after attaining its viability.

AND WHEREAS it is being increasingly recognized that national prosperity is primarily a function of Education, Healthcare, Agricultural Training, Dairy Farming & Environment-awareness, and the Government of India and the Government of West Bengal have shown active awareness of this important concern and are encouraging the development of education and Healthcare & Environment-awareness;

AND WHEREAS for good reasons and considerations and in order to perpetuate the aforesaid cherished and pious desire, for the purpose of better administration and with the objective of providing Education, Healthcare & Environment-awareness in its most effective

form the SETTLOR has decided to constitute a Trust for the purpose of founding, acquiring, managing and continuing institutions for propagating the aims and objects so cherished by the SETTLOR;

**AND WHEREAS** the SETTLOR is desirous of forming a Trust for propagating and imparting Education, Healthcare & Environment-awareness, and has, for this purpose, contributed a sum of Rs. 10,000/- (Rupees ten thousand only) towards the corpus of the Trust;

**AND WHEREAS** The Trustees have agreed to become Trustees and to hold and apply the said sum of Rs. 10,000/- (Rupees ten thousand only) and all gifts, contributions, subscriptions and donations to the said fund including all additions and accretions thereto (hereinafter referred to as "the Trust Properties / Funds") for the objects of the trust as per provisions contained in this deed.

NOW THIS INDENTURE WITNESSES AS FOLLOWS:-

1. In pursuance of the said wish and desire of the SETTLOR, the SETTLOR does hereby grant, convey, transfer, assign and assure to the TRUSTEES ALL THAT property described in Schedule below TO HAVE AND TO HOLD them all upon trust for the objects and with the intent and subject to the powers, provisions and agreements hereunder declared and expressed concerning the same.
2. The name of the Trust shall be DR. PATRA'S EDUCATIONAL TRUST, BURDWAN. The Registered Office of the Trust shall be situated at Flat no. 401, Santi Apartment, 31 A, S.P. Mukherjee Road, Kolkata-700025 and local office at Kanainatsal, G.T. Road, P.O. Sreepally 713 103, P.S. & District Burdwan. The Trustees shall have power to change the registered office of the Trust, if they so decide. The secretariat / working office of the Trust will be located at such places(s) as may be convenient to the Trustees, who shall have similar power to change its location if they so decide.

### 3. OBJECTS OF THE TRUST

The object of the Trust shall be any or all of the following:-

- (a) To facilitate advancement and propagation of education, among all without any distinction of caste or creed, but with preference for children belonging to 'middle-class society' through establishment, administration, maintenance and support of schools, colleges and other educational institutions, and Healthcare, Agricultural training, Dairy Farm, Environment awareness, Occupational Therapy Institutes, and the Government of India and the Government of West Bengal have shown active awareness of this important concern and are encouraging the development of Education and Healthcare and Environmental awareness;

(b) To impart education on commercial, scientific, humanities, technical, physical training, performing arts streams and/or any other type or kind of education at primary, secondary and higher secondary and college level.

(c) To acquire, establish, commence, aid, take over management, administer or run any Institution, school, college engaged in the imparting of education to students up to any level that may be found necessary and / or desirable.

(d) To generally impart education to students with preference for 'economically challenged', socially marginalized, and underprivileged children, and for the purpose to do all acts that may be necessary for ensuring the same.

(e) To guide research and to encourage in publications.

(f) To promote all forms of education, child or adult, formal or informal.

(g) To hold, arrange and organize meetings, lectures, talks, discussions, symposia, conferences, competitions, study visits, tours, excursions, exhibitions, debates, audio-visual programs, artistic performances and other cultural activities, sports and games.

(h) To establish, maintain and support libraries, museums and reading rooms and distribution of books etc., for advancement for education and knowledge in general.

(i) To provide and meet all expenses of the school and other educational institutions.

(j) To provide education in the field of socially useful and productive work and community service, Scouts and Guides, Leadership Training activities, extension of Human Development and growth and strengthening of human values.

(k) To arrange the advancement of any other object of general public utility and relief like conducting seminars on educational advancement, providing necessary assistance during calamities, public awareness programs and such other assistance as may be required from time to time.

(l) To acquire, establish, commence, aid, take over management, administer or run any Home(s) for Senior Citizens and/or for economically challenged children coming from the poor and under-privileged sections of society that may be found necessary and / or desirable.

(m) To train persons to be Teachers who will impart education to 'economically challenged, socially marginalized, and under-privileged' children, and/or students in schools, colleges and other similar institutions.

(n) To hypothecate, mortgage or otherwise create charges / liens in respect of all or any part of the property of the Trust as security for financial accommodation availed from any bank or financial institution.

(o) To undertake any or all of the above objectives, and engage and assist in all such philanthropic activities and do all such things as may be deemed incidental or conducive

#### 4. TRUSTEES

(a) The first Trustees shall be:

- i) DR ASIT BARAN PATRA, M.Sc., M.B.B.S., D.P.M., son of late B.C. Patra, residing at Kanainatsal, G.T. Road, P.O. Sreepally – 713 103, District Burdwan: Medical Practitioner (Psychiatrist), Past District Governor;
- ii) DR GOURI PATRA, M.Sc., Ph.D. wife of Dr Asit Baran Patra, residing at Kanainatsal, G.T. Road, P.O. Sreepally – 713 103, District Burdwan Head: Dept of Chemistry: MUC College, Past District Governor;
- iii) DR. SAYANTAN PATRA, M.B.B.S., D.P.M., son of Dr Asit Baran Patra, residing at Kanainatsal, G.T. Road, P.O. Sreepally – 713 103, District Burdwan, Medical Practitioner (Consultant Psychiatrist).
- iv) DR. SWAPNADIP THAKUR, M.Sc., D.Phil., son of late Shankarananda Thakur, residing at University Teachers' Co-operative Housing Society, Krishnapur Road, Town, P.O. & District Burdwan, PIN 713 104; Professor & Head: Dept. of Chemistry: University of Burdwan.
- v) DR SUNIL KUMAR BHOWMICK, M.B.B.S., son of late Himadri Shekhar Bhowmick, residing at 46/3/11 Biplabi Barin Ghosh Sarani, Kolkata 700 054, Medical Practitioner, ex-C.M.O.H., Addl Director of Health Service (Ophthalmology), Surveillance Medical Officer N.L.E.P.
- vi) SRI SUKANTA BHOWMICK, M.Sc., W.B.C.S., ex-Joint Secretary L & LR Department, Govt. of West Bengal, son of late Himadri Shekhar Bhowmick, residing at 2 Sri Ram Estate, Flat B-IV, 129 Ho Chin Minh Sarani, Kolkata 7000 078.
- (vii) DR DEBESH THAKUR, Teacher: C.M.S. School, son of Late Suresh Chandra Thakur, residing at 46A Kalibazar, P.S., P.S. & Dist. Burdwan 713 101 is an eminent cultural personality, Poet and author (hereinafter called "the TRUSTEES" )

And these 7 members will be the FOUNDER TRUSTEES and will constitute the First Board of Trustees.

- (b) The maximum number of Trustees in the Board shall be nine.
- (c) The Trustees shall appoint a Secretary Trustee and a Treasurer Trustee from the Trustees of the Trust.
- (d) The responsibilities of the Secretary Trustee shall include:-
  - i) To supervise and monitor the day to day functioning of the Trust as per directions of the Board of Trustees.

- ii) To ensure that all the institutions under the Trust are being run efficiently.
- iii) To call meetings of the Trustees at reasonable intervals, issue notices, prepare agenda and to maintain the "minutes" of the meeting.
- iv) To sign all legal documents for and on behalf of the Trust, taking approval from the Board of Trustees wherever necessary, and to appear before all legal, statutory and other authorities as may be required from time to time.
- v) To ensure that the objects of the Trust are being achieved in a harmonious manner.

(e) The responsibilities of the Treasurer Trustee shall include:-

- i) To keep the books of accounts of the Trust.
- ii) To operate the Bank Accounts of the Trust, jointly with another trustee who does not come within the family of the SETTLOR.
- iii) To ensure strict control over the funds of the Trust.
- iv) To invest the funds of the Trust as per the provisions of the Income Tax Act and as per directions of the Board of Trustees.
- v) To get the Accounts Audited annually and comply with all legal formalities.
- vi) To take approval from the Board of Trustees before receiving any donation, gift, legacy or subscription by cash, cheque, ECS, NTFs, RTGS.
- vii) To appraise the Board of Trustees of the financial position at the meetings of the Board of Trustees.

f) All the seven Founder Trustees shall hold Office during their respective lifetimes subject to clause (g) hereunder.

g) A Founder or co-opted Trustee shall cease to hold the office of Trustee on any of the following grounds:-

- (i) on resignation,
- (ii) on the Trustee becoming insane or lunatic,
- (iii) on the Trustee being convicted of any offence involving moral turpitude by a Court in India and abroad,
- (iv) on the Trustee being removed from the Board of Trustees by a majority decision of the Board for having acted contrary to the aims, objects and purposes of the Trust.

6. POWER OF TRUSTEES:

- a) To manage, supervise and secure the Trust Funds and assets, and collect, recover and deposit the same, and to pay thereout the expenses of collection and all other approved outgoings, of the Trust.
- b) The Trustees shall have all powers to do all things as may be required for achieving the aims and objects of the Trust and in the interest of the Trust, whenever, such powers are not found to have been specifically conferred by this document..
- c) The Trustees shall be entitled from time to time to open, maintain and operate a Bank Account or Accounts in the name of the Trust or in the name of the school / college / institution at such Bank(s) as they may from time to time decide, and may at all times pay or cause any monies forming part of the Trust Fund or School / College / Institution Fund to be paid into the credit of any such Account or Accounts either by way of Fixed Deposit or Current Account or S/B account or any other Account. All such accounts shall be operated jointly as per clause 4 (e) (ii) of this Deed.
- d) The Trustees shall have powers to commence, maintain and defend all civil / criminal / revenue proceedings and take all such other steps as may be reasonable and requisite for the preservation and protection of the Trust property with the help of and in consultation with professionals. The Trust may sue and be sued in the name of the Trust.
- e) The Trustees shall be subject to all the liabilities cast upon them under the Indian Trusts Act of 1882 except to the extent of the powers specifically conferred under these presents.
- f) Subject to the prior approval of the Board of Trustees, any Trustee may at any time receive voluntary contribution from any person or persons by donation, legacy, gift, any land with or without building, any fund or annual or monthly subscription for the benefit of the Trust. The Trustees shall apply such contribution in accordance with the objects of the Trust.
- g) Proper Accounts showing all receipts and disbursements made on account of the Trust hereby constituted shall be kept by the Trustees, who shall prepare "Receipts and Payment Accounts", "Income and Expenditure Accounts" and "Balance Sheet" as on March 31<sup>st</sup> every year, which shall be duly audited and vetted by the Trustees. The Trust shall maintain "Books & Accounts" as required under section 15(1)(a), (b) of The I.T. Act. The Accounts shall be audited by a duly qualified Auditor, as stated in section 15(2) of the said Act.
- h) The Trustees may from time to time appoint Accountants, Clerks and other Officers / personnel as the Trustees may deem expedient, and fix and pay their remuneration out of the Trust fund.

i) The Trustees shall have power to raise or borrow for the purposes of Trust from time to time in the name of the Trust or otherwise on behalf of the Trust such sums of money as they may from time to time deem fit.

j) All the funds of the Trust shall be invested as per the provisions of the Income Tax Act of 1961 or its amendments thereto.

k) The Trustees shall have the power to amalgamate this Trust with any other Trust or charitable institution having objects and purposes mainly similar to that of this Trust as the Trustees for the time being in office shall deem fit and proper.

l) The Trustees shall constitute separate Managing Committees for the long term and day to day administration of each school, college, institution, homes for Senior Citizens and economically challenged / under-privileged children under the Trust. The Board of Trustees shall nominate one of the Trustees to be the ex-officio President of each such Managing Committee.

m) The Trustees may decide matters by circulation without any meeting, and a resolution if passed without a meeting by circulation evidenced in writing under the hands of 2/3<sup>rd</sup> Trustees of the Trust shall be as valid and effectual as a "resolution" passed at the time of meeting of the Trustees.

n) The notice of all meetings of the Trust and all communications to the Trustees may be sent to the Trustees at their addresses registered for the time being in the records of the Trust. All such notices shall be recorded in the 'Notice Book'.

o) The "minutes" of the proceedings of every meeting of the Trustees shall be entered in a "Minutes Book" to be kept for the purpose and signed by the Chairman of such meeting, and the same shall be read and confirmed at each successive meeting with / without modifications, and shall when so confirmed be conclusive evidence of the business and other matters actually transacted at such meetings.

#### 8. ACCOUNTS & AUDIT :

The accounting year of the Trust shall be the financial year commencing from 1<sup>st</sup> April and ending on the following 31<sup>st</sup> March. The Accounts of all schools / colleges / institutions founded / managed by the Trust shall be maintained separately. The Accounts so prepared and maintained shall be duly audited by Auditors appointed by the Trustees.

h) In the event of a vacancy occurring in the Board of Trustees for any of the reasons specified in clause (g), the same shall be filled-up within a period of 3 months by co-opting any person considered to be suitable by a majority of members of the Board.

5. **MANAGEMENT:**

a) The management, supervision and control of the property and affairs of the Trust aforesaid shall be vested in the Trustees with full powers and authority to purchase both freehold and leasehold properties, obtain leases and accept gifts of land / hereditaments / funds / assets, and possess, control and secure the same and construct any building(s) for the objects of the Trust at any time, subject to these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and other Charities as they deem fit, and to add / alter or vary the same from time to time as may be considered necessary provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and/or with the provisions of any statute and specially the Income Tax Act, 1961, the Trust Act, 1882 and all amendments thereto.

b) The Trustees shall meet as often as possible but not less than four times in a year for efficient management of the Trust, to consider the income and expenditure and for disposing of all such other matters as may arise in such meetings.

c) At all meetings of the Trustees, three members will form the quorum.

d) At all meetings of the Trustees, the SETTLOR or in her absence the Secretary Trustee or in the latter's absence one of the Trustees by co-option shall act as the Chairman of such meeting.

e) All decisions of the Trustees shall be by majority vote. The Chairman shall have a casting vote in case of a tie of votes.

f) All proceedings of the meeting of the Trustees shall be recorded in a 'Minutes Book' kept for the purpose by the Secretary.

g) Trustees who fail to attend three consecutive meetings without prior intimation or information shall cease to be Trustees, unless the majority of the other Trustees accord him exception on genuine and valid grounds.

9. WINDING-UP

(a) This Trust has been created to be in existence in perpetuity.

(b) Though not envisaged, in the event of the dissolution or the winding up of the Trust, under whatever circumstances, the assets / establishment / funds remaining in credit on the dissolution shall be transferred to another Trust, Society or Institution whose objects are similar to those of this Trust, and in no event shall the assets / establishment / funds so remaining be distributed among the Trustees.

10. The activities of the Trust shall under no circumstances be conducted beyond the boundaries of India. All the objects of the Trust shall strictly be restricted to India.

11. The Trust shall be governed by the Indian Trust Act, 1882 and/or its amendments. All the powers and provisions hereof shall be construed as being subject to the restrictions and limitations therein contained.

12. The Trust will remain valid for 60 years from date of Registration.

13. The Trust is of Charitable, non-profit and non-proprietary character in nature.
