

I. Road, Post Sripally, 713103, Dist. Burdwan hereinafter referred to as the 2<sup>nd</sup> Party or the Donee unless excluded by its executors, assigns, administrators of the other part.

Whereas the property mentioned in SCHEDULE-A below bearing plot No. 550 previously belonged to Bholanath Ghosh and 5 others whose name had been duly recorded in the R.S.R.O.R. and L.R.R.O.R. and they were in exclusive possession.

And whereas during their possession they transferred the entire 16 annas acres in favour of the donors and their sons Dr. Sayantan Patra and Dr. Suchindram Patra by virtue of deed of Sale being Nos. 7247, 7411, 7412, 7413 and 2630 respectively for the year, 1988 and 1989 registered before A.D.S.R. Burdwan.

and whereas in plot No. 543 of 'B' SCHEDULE property originally belonged to Dr. Sayantan Patra and who transferred the same in favour of Dr. Suchindram Patra by dint of regd. Deed of gift being No. 4931 for the year 2000 registered before A.D.S.R. Burdwan.

And whereas Dr. Suchindram Patra transferred the said plot of land in favour of his mother namely Dr. Gouri Patra, Donor No. 2 by virtue of a regd. Deed of gift being No. 3965 for the year 2012 registered at A.D.S.R., Burdwan.

And whereas Dr. Gouri Patra accepting the said Plot of land and her name has been duly recorded in I.R.R.O.R.

And whereas Plot No. 543/793 of 'B' scheduled property previously belonged to Dr. Suchindram Patra who acquired the right, title and interest by virtue of a deed of sale being No. 8354 for the year 1978 and thereafter Dr. Suchindram Patra transferred his all right, title and interest in favour of the Donor No. 2 of this deed by dint of registered deed of gift being No. 3966 for the year 2012 registered at A.D.S.R. at Burdwan and her name has duly been recorded in the I.R.R.O.R.

And whereas thus in respect of 'A' SCHEDULE property in Plot No. 550 Dr. Asit Baran Patra became lawful owner and possessor of 15 cents of land.

And whereas in 'B' SCHEDULE Dr. Gouri Patra became lawful owner and possessor of 34 cent in plot No. 550, 85 cents in plot No. 543 and 60 cents in 543/793 no plot and thus both of them discharging their legal duties and liabilities in their respective shares.

And whereas out of donors' admiration, love and regard, respect towards the donee's social activities the donors are serious of making a gift of the 'A' & 'B' SCHEDULE property which they own and possess and in this connection the donors offered to make a gift in respect of schedule property in favour of the donee and the donee agreed to accept the said gift.

And whereas in terms of the offer on the part of the donors as well as acceptance of the gift on the part of the donee, the donors have thought it fit to execute and register the necessary deed in favour of the donee in respect of donors' schedule property of this deed and in pursuance of the said wish and desire the donors doth hereby herenunder freely voluntarily grant convey, transfer, lease, charge, mortgage, gift, sale, assign and assure unto and to the use of the donee and its successors to that properties mentioned in schedule hereunder to be used exclusively and exclusively for the donee's benefit and the donee to have and to hold the same for its social purpose and has all the rights of alienation for generation together and also the donors delivered the possession of the same unto and in favour of the donee to have and to hold the same for its sole use and benefit absolutely and unconditionally for ever.

Now this deed of gift witnesseth as follows:-

That the donee accepts the gift of donors' schedule property as mentioned hereunder with all rights of enjoyment and facilities owned and possessed by the donors, his rights, duties and obligations which the donor discharged.

That the donors further expressly submits that schedule property has neither previously been transferred by the donors nor any encumbrances has been created by the donors and the donors have not charged, agreed to transfer the same with the 3<sup>rd</sup> Party and the donors' schedule property is free from all encumbrances. In future if any dispute arises or occurs with reference to the title and possession of the donor, the donors shall get it removed before all courts of law and Authority.

That the donee's Trust shall become sole and absolute owner, possessor in respect of donors' property mentioned in schedule hereunder and shall enjoy the same freely and openly. That the donee shall be in full liberty to establish a school in the name & style as Swami Vivekananda Academy for Educational Excellence or college or any other educational institution in other name constructing multi storied building thereon. i.e schedule property is lying unencumbered. In spite of that if any defect in the title and possession of the donors be found that would be solved by the donors.

That the donee will be entitled to get its name recorded in the Records of Rights, Conversion, mutation in respect of schedule properties and it will also have the right to pay land revenue and taxes to the concerning Authority in its own name continuously in respect of the same and the donors are giving consent to that effect and the admission made in this deed shall be deemed to be the consent of the donors and donee shall have the authority to delete the name of the donors from the registers maintained by the Superior Landlord or the State Government and shall get his Trust name mutated.

That the donors never held any land or property beyond the statutory ceiling and as such no part of the schedule property has vested with the State of West Bengal.

That for the purpose of valuation of the property, the entire schedule property has been assessed valued at Rs. 2,85,79,954.00 (Rupees Two Crore eighty five lacs seventy nine thousand nine hundred fifty four) over which stamp duty is paid by Rs. 5,000/- India Non Judicial Stamp and the rest amount by Bank Draft.

The impression of ten lingures and two sets of passport size photographs of the donors and donee are given in a separate sheet annexed with this deed of gift and the same will be treated as part of this gift deed.
