Condition Applied :-

- 1.Driveway must be free of any type of obstruction for easy movement of Fire Appliances. No parking will be allowed on the Drive way.
- 2. Entrance /Exits as marked in the sanctioned plan drawing must be opened and free from any type of obstruction.
- 3. The Interior finish decoration of building shall be made with low flame spread material confirming to the I.S. Specification.
- 4. To eliminate risk of Fire Hazards, Good House Keeping both for insides and outside of the building shall be strictly maintained.
- 5. Existing Electrical wiring of the whole building shall have to be carefully checked for any wear and tear in them, particularly lines above false ceiling & ducts.
- 6.No inflammable articles shall be stored inside the store room.
- 7. The notice of Fire Fighting and Evacuation from the building shall be prepared and displayed at all vulnerable places of the building.
- 8. The employees and security staffs shall be conversant with installed fire fighting equipments of the building and to operate in the event of fire and testing.
- 9.Mock Fire practice and evacuation drill shall be performed periodically with participants of all the occupants of the building.
- 10. Transformer, switch gear, main & meter room shall be protected with CO2 or DCP Fire extinguishers confirming I.S. specifications.
- 11.A crew of trained Firemen under an experienced officer shall be maintained round the clock for fire safety of the building.
- 12. First Aid fire fighting system shall be provided as per I.S. specifications.
- 13. Arrangement shall have to be made for regular checking, testing, and maintenance of all the Fire Fighting installation in the building to keep them in perfectly good working condition at all the times.
- 14.If required the old electrical lines shall have to be replaced with new lines. The cables shall always be laid in M.S. conduit pipes continuously bonded to the earth.
- 15. All pumps and detection system which are incorporated in the building shall be kept in auto mode round the clock.
- 16. The Fire Safety audit to be conducted at regular interval and to be recorded in the Fire Prevention maintenance register.
- 17. Emergency lighting system (Battery Backup) to be installed in the staircase for the safe evacuation.
- 18. Electrical audit shall be conducted in every year and a certificate must be submitted in this office at the time of renewal of fire safety certificate.
- 19. This Renewal of Fire Safety Certificate is valid for 3 years as per existing Govt. Rule and has to be renewed as per existing Govt. Rule from the date of issue of this letter.
